REGISTRATION INFORMATION AND TERMS AND CONDITIONS

REGISTRATION

To secure a place on any of our training initiatives, please return the registration form via email to training@tstat.eu. Places can also be reserved via email; participation will not however be confirmed until a completed course registration form and payment is received. The course will be officially confirmed when a minimum of 5 participants are officially enrolled. Please note that participation on all our courses is limited to a maximum of 8 individuals. Places will be allocated on a first come, first serve basis. Early registration is therefore, recommended. For administration purposes, registration on all our training initiatives closes 10 days before the starting date of the course. Unless otherwise indicated, training courses will be in English.

REGISTRATION FEES

- Fees are subject to VAT (applied at the current Italian rate of 22%). Under current EU fiscal regulations, VAT will not however applied to companies, government institutes or Universities providing a valid tax registration number.
- To be eligible for **full-time** student prices, participants must provide proof of their **full-time student** status for the current academic year. Our standard policy is to provide all full-time students, be they Undergraduates or Masters, access to our student registration rates. Part-time master and doctoral students on the other hand, who are also currently employed will be assigned the standard academic registration fee.
- Multi-participants pricing: a 10% discount is applied to the second participant and a 15% discount is applied to each additional participant from the same company or academic department enrolling on the course. Students and doctoral students are however, exempt from TStat's multi-participant offer.
- TStat Training's Annual Training Program: individuals (with the EXCEPTION of undergraduate, master and doctoral students), attending more than one of our training courses during 2026, will be entitled to a 10% discount off their second course and a 15% on any subsequent course fees.
- Training fees cover: teaching materials (handouts, Stata datasets and routines specifically developed for the course), a temporary licence of Stata valid for 30 days from the beginning of the course.
- Participants also have the right to a 20% discount off the purchase of a single user academic or commercial perpetual licence of Stata. Licences purchased under the student licensing Program are however excluded from this offer.

CANCELLATION POLICY

Written notification of cancellation should be sent by email to training@tstat.eu, at least 21 calendar days prior to the start of the course, should circumstances prevent the delegate from attending the course concerned. Written cancellations received within 21 calendar days of the course starting date do not incur a cancellation penalty. Participants will however, be liable for any bank transfer costs incurred should it be necessary to refund course fees. Participants who cancel between 10 and 20 calendar days prior to the course starting date, will be subject to a service charge equivalent to 50% of the total course fees. The participant will also be liable for any bank transfer costs incurred should it be necessary to refund the balance of previously paid course fees. Participants who cancel less than 10 calendar days before the start of the course will be liable for a cancellation charge equivalent of 75% of the total course fee. Participants will also be liable for any bank transfer costs incurred should it be necessary to refund the balance of previously paid course fees.

POSTPONEMENT OF PARTICIPATION

Requests can be made to postpone their participation to the next subsequent course. Individuals must, however, send written confirmation of their intention to postpone within 21 calendar days prior to the start of the course concerned. Requests for postponement received after this date will incur a service charge equivalent to 25% of the original course fees. Requests for postponement received 10 or less working days before the start of the course will be subject to a service charge equivalent to 40% of the original course fees.

TRANSFERING REGISTRATION TO ALTERNATIVE COURSES

Participants wishing to transfer their registration to an alternative course, must send in a written transfer request no later than 15 calendar days before the start of the course. Requests received within 15 days prior to the first day of the original course will incur no additional fees. Individuals who communicate their intention to transfer to another course between 8–14 calendar days prior to the first day of the original course are subject to a service charge of 25% of the original course fee. Participants who transfer to another course 7 days or less, prior to the first day of the original course, are subject to a service charge of 40% of the original course fee. Please note that refunds cannot be made given to individuals requesting a transfer on or after the day the original course begins. Moreover, participants will also be liable for any bank transfer costs incurred should it be necessary to refund the balance of previously paid course fees.

OFFICIAL CONFIRMATION OF COURSE

TStat reserves the right, to either cancel or postpone the course, should the minimum number of participants not be attained. Official confirmation of the course will be given to participants via email 9 calendar days before the starting date. Should it be necessary to either cancel or postpone a course to a later date, participants have the right to either transfer their original registration to the rescheduled course or to cancel their participation completely. In the case of cancellations, all pre-paid course fees will be fully reimbursed via bank transfer.
